Terms and Conditions

Eligibility to participate in the 2024 Lifestyle Holiday event is contingent upon Vyvo Members meeting the qualifying criteria.

1. TRIP LOCATION

Koh Samui, Thailand

2. TRIP DATES

Arrival: June 25th, 2024

Departure: June 30th, 2024

3. QUALIFICATION PERIOD

Starts: January 23rd, 2024

Ends: June 3rd, 2024 (*based on 11:59 p.m. Singapore Standard Time*)

4. EVENT QUALIFICATION RULES

To qualify for the Lifestyle Holiday, you must earn a minimum of 2,000 Lifestyle Points.

Lifestyle Points	Reward
2000 LP	Accommodations for two/ no flight contribution
3000 LP	Accommodations for two/ 1 flight contribution
4000 LP	Accommodations for two/ 2 flight contributions

5. LIFESTYLE REWARD POINTS ACCUMULATION

How to earn Lifestyle Points:

- For every 1,000 Hub Volume (HV) generated from your direct Connections in the Hubs, earn 50 Lifestyle Points
- Receive an additional 100 Lifestyle Points for every 5,000 HV accumulated from your direct Connections in the Hub
- For each Epoch, earn 100 Lifestyle Points for every 5,000 Payable HV in Community USDV
- Achieve or confirm Premier 1 Star rank within the specified period to receive a one-time bonus of 200 Lifestyle Points

6. AIR TRAVEL

It is important to understand that any travel arrangements, including flight bookings, made prior to the approval of your visa are at your own risk. Vyvo is not liable for any expenses incurred should your visa application be delayed or denied. Qualifying Members are encouraged to consider travel insurance or refundable tickets where possible to mitigate potential losses.

To clarify, qualifying Members who earn 4,000 or more Lifestyle Points will earn the flight contribution listed here twice (i.e., two flight contributions).

7. ACCOMMODATIONS

Bask in true luxury at the Melia Koh Samui resort, one of the world's most beautiful travel destinations. Qualifying Members will receive hotel accommodations, paid by Vyvo. The hotel room is for 2 persons, and the accommodation is for 5 nights, with breakfast included.

Qualifying Members can check into the hotel from 2:00 PM on the day of arrival and must check out by 12:00 noon on the day of departure.

The first 80 qualifiers will be accommodated at the Meliá Koh Samui Resort, which is the maximum number of guests we can host there.

Qualifiers beyond the initial 80 will be provided accommodation in a hotel of equal quality, details of which will be communicated at a later date.

8. MEALS

Breakfast is provided each day in the hotel. Holiday travelers will enjoy one group dinner during the event. All other meals are the responsibility of travelers.

9. INCIDENTAL CHARGES

No incidental charges are covered. At check-in, a credit card will be required on which a hold of 10,000 baht will be placed, or a security deposit will be required in case of incidental charges.

10. AIRPORT GROUND TRANSFERS

Transfers from the airport to the hotel for check-in and check-out are provided only on the event dates. Qualifying Members are responsible for arranging and paying for any additional transportation needs.

11. **ACTIVITIES**

We're excited for you to explore this amazing destination. Therefore, we will offer some activities for our qualifying Members, along with free time for you to discover the area on your own. Your participation in specific event activities will be confirmed at check-in.

12. **NON-TRANSFERABLE**

This trip is non-transferable and cannot be converted to cash. Qualifying Members are required to attend the destination for which they have qualified. The company will not accommodate requests to attend a future trip or provide any form of substitute compensation under any circumstances.

13. **CONFIRMATION**

Trip earners must confirm their participation through the method that will be released and announced by the company. Without this confirmation, participation in the organized holiday cannot be guaranteed. Confirmations must be submitted no later than June 7, 2024.

14. **CANCELLATION**

Vyvo requires notification of any cancellations for the Holiday by June 7, 2024. Trip earners who cancel after this date will incur a cancellation fee of US\$2,000, deducted from their commissions. If the available commission funds are insufficient for the full deduction, the amount will be reduced by whatever is available until the total fee is covered. The same process applies to those who confirm attendance but do not show up.

15. **EXTENDING YOUR STAY**

For Qualified Members choosing to arrive earlier or stay later than the specified event dates, arranging and paying for accommodations at the Melia or any other hotels is their responsibility. Additionally, Vyvo does not guarantee ground transfers at its expense outside these dates. If you plan to book your stay at the Melia beyond the event dates, please mention that you are part of the Vyvo group for June 25-30.

16. **MEMBERS' RESPONSIBILITIES**

Members are required to adhere to all stated Rules and Regulations without any violations before and during the qualification period. Violation of these terms will result in disqualification from participation. Trip earners are also responsible for obtaining any necessary visas and covering all expenses related to securing required travel documents before the trip.
